END USER LICENSE AGREEMENT

THIS END USER LICENSE AGREEMENT ("**Agreement**") governs your use of *The 2024-25 Economic Report on Pharmaceutical Wholesalers and Specialty Distributors* ("**Report**") provided by HMP Omnimedia, LLC, an HMP Global Company, d/b/a Drug Channels Institute, ("**DCI**") under this Agreement made available to, or accessed by, you ("**Purchaser**"). Purchaser may cite this Report in commercial documents with full and appropriate attribution. - 1. <u>License from DCI</u>.
